 59 attendees at May Milonga
 Revenue from this first practica was \$258.00 (18 count single-session admissions and
 3 count 10-pac session admissions at \$50.00 each. Rent expense for the practica space
 of \$580.00 was paid during May. This rent amount pays for 12 weeks of
 practica space. With revenue of \$258.00 and expense of \$580.00, the May net loss for
 the practica was \$322.00. PayPal transaction fees related to practica-session
 purchases were \$13.05.

- 7. Northrop Amplifying Solidarity Cathy: July 2022 from 12 1 pm with Charles Grysinski Quartet. Instructors will be invited to participate.
- 8. JULY 9th: Argentine Independence Day TOM'S PLACE Fran: Tamara and Liliana advised that there's an Argentine Association will have a concert at a restaurant. Tamara and Liliana will be participating in both the TSoM dance and the Argentine Association's event. Jack suggested we might have a pop up milonga at one of the Argentinian restaurants.
- 9. Eventbrite Eduardo: added to agenda as discussion item. Fran assigned research task to Eduardo and Shannon to determine if we should begin using them for ticketing.
- 10. Practica SUCCESS Jack, Sandy: Michael & Renee, Lois, Rebecca, and Lois have all agreed to come to the practicas for the next series. A question was posed by Sabina: How are we going to get more dancers?
- 11. Don Rowe who in TSoM could train in as an assistant Fran: Recommend he have a lifetime membership or get into all milongas for free and/or Tango Treasure Recognition. Eduardo recommended Paul be recognized for sending the TSoM newsletter. Fran has been handling the newsletter while Paul has been out of town in April and May. Kathya recommended we continue the conversation to determine our recognition. Action: Cino will advertise this through the membership committee. Eduardo and Kathya volunteered to help with the TSoM website. Don is not yet planning to leave there's a need for someone to act as a backup.
- 12. TSOM plan a river cruise Jack: There's a need for 65-75 people to sign up to generate about \$300 in revenue. It was normally held in August, but TSoM is already booked for August. The earliest date would be September. Discussion centered

around whether the board has bandwidth, then Eduardo added the question "how does this fit into our mission?" He's in favor of outward facing instead of inward facing, like a cruise. Eduardo is creating a Milonga Pop-up Calendar with the hope of creating a public outreach event at least 1 event every month.

- 13. TSoM and participation in the Minneapolis Dinner in White on June 25 Eduardo: It was a lot of work to create the ambience (chairs, dance floor, music, lights) and Terri coordinated a 2nd team. Jack suggested combining Mala Yunta with the June 25th event. Motion: Fran moves TSoM undertake participation in the Minneapolis Dinner with Eduardo's lead. Sandy seconded, unanimous vote.
